## **General important notes**

Providing and advertising with sexual services of pregnant women and sexual practices without a condom is prohibited. In the case of breaches, free / customers may be punished with a high fines of penalties. The condom duty is also valid for oral and anal practices.

Police, customs, tax inspectorate, administrative office and building authority may inspect all areas in which prostitution is carried out and inspect business records to monitor the sex industry. Personal controls may also be carried out at any time. The information may not be refused by interested parties, but they must respond only to questions which can also be found in the documents. Explanations of the Prostitution Protection Law

Beratungsstelle für **Prostituierte** 

On 1 July 2017, the Prostitutes Protection Law (**ProstSchG**) entered into force. The regulations contained therein concern prostitutes and the operation of prostitute sites.

These are briefly summarized below. If you have questions, we are happy to help!

## For sexworkers

Sex work or prostitution is the repeated execution of sexual services before or at at least one additional person or admitting at or before themselves for money or money-worthy advantages (also eg. Dominas, Escort, Tantra, sexual accompaniment, erotic massages!) No matter whether the activity is carried out regularly or only occasionally. Only those who are officially registered as prostitutes may also work in prostitution.

#### The obligatory health advice:

- every 12 months at the health office (under 21-year -old every 6 months): costs 35 € (in Bavaria)
- NO examination! Only information on the topics of hygiene and health is given.
- After this conversation a certificate will be issued which must be brought to the registration (health care certificate).
- The passport must be submitted for the certificate.
- Furthermore no details have to be given. No details are required.

## Registration:

- Personally every 24 months with the responsible authority (under 21 years every 12 months): Cost 35 € (in Bavaria)
- Starting at 01.07.2017 new sex workers have to register themselves before the start of work.
- For men and women who have already worked before 01.07.2017 there is a transitional period until the 31.12.2017.

- You must bring along: two biometric passport photos, ID card / passport, health care certificate
- Registration is possible throughout all of Germany.
- When registering, counseling on the rights and obligations of prostitutes will be given. The data of the registered person will be forwarded to the responsible financial authority.
- The registration authority may ask for an existing pregnancy also about a certificate on the stage of pregnancy and reject the application 6 weeks before the date of birth.

The authority shall issue a **registration certificate** after 5 days at the latest. Only with this is it legal to work as a prostitute \* r.

# The certificate of health advice and the paper of registration must always be carried to work.

- The certificates can additionally be issued in an alias / artist name. Costs: € 35 each (in Bavaria)
- The certificate is valid as proof of correct registration against operators, etc.
- The certificate is to be submitted to the request of control authorities (eg police)

**Personal data** from the application (name, address, etc.):

- May not be passed on to private persons
- are communicated to the tax office (prostitutes must report to the tax office independently and pay taxes!)
- Are sent to the police maybe (not shure by now)
- may be used to clarify administrative offenses and to prosecute those relating to the ProstSchG

## For operators \*

In a prostitute, the person who offers sexual services by at least one other person or at least one person provides rooms for the practice of prostitution (also cars, studios, agencies or events).

Except are prostitutes who work alone in their own apartment, mainly used for living.

## Prostitute sites need a license (concession):

- This must be reported by 01.10. at the responsible administrative office and applied for by 31.12.2017.
- · Costs: depends on the size of the company
- The operating permit does not replace the approval of the responsible building authority
- For further information, please contact the local office.

As of 01.01.2018, only prostitutes with a valid registration certificate are allowed to work with them. You also have to document daily who worked with them. In addition, they must submit all contracts and agreements to the tenant in writing.

Furthermore, they need to provide condoms and lubricants for the work.
